## ZION LUTHERAN SCHOOL ATHLETICS

### ELIGIBILITY STANDARDS OF ZION LUTHERAN SCHOOL

Where letter grades are applicable, a student will become ineligible if he/she receives an F or two (2) D's or an Unsatisfactory in Citizenship (student's attitude, conduct, or behavior that is not acceptable in our school) where letter grades are not given.

### PROBATIONARY PERIOD

At any time when a teacher sees a student not meeting the standards of Zion Lutheran School, he/she will be placed on a Probationary basis for a period of two weeks. During these two weeks the student must raise his/her grades or citizenship to the standards of the school. At the time of probation, the teacher must notify the parents and coach(es) of this probationary period. During these two weeks, the student will attend and be able to participate in practices. **The student will not be able to participate in games during this probationary period.** If the student is not able to raise his/her grades or citizenship mark to the standards of our school, the student will then be removed from the team for the remainder of the season. A student may only be on probation once per season.

### APPEAL PROCESS

An appeal to the above standards may be made by the parents of the student. The appeal should be made to the principal. A review committee will hear the reasons why an exception should be made to the above standards. The review committee shall consist of the school principal, the teacher(s) of the student, the Athletic Director, and the coach. For an exception to be made, a unanimous decision must be given by the review committee.
